

## Cookie Policy

The SCP Srl website, **www.sconline.it**, or the “Site” uses Cookies to simplify its services and increase efficiency when the user visits pages on **www.sconline.it**.

Users visiting the Site will see minimum quantities of information inserted on the devices they are operating, whether a computer or mobile device, in small text files called “cookies”, saved in the directories used by the User’s web browser.

There are various types of cookies, some to simplify the use of the site, others to enable specific functions.

Upon close examination, our cookies permit us:

- to save preferences that have been entered;
- to prevent users having to enter the same information, such as username and password, more than once during a visit;
- to analyse the use of the services and the contents supplied by **posizionamento-seo.com** and thereby optimise user experience and the services offered

### Types of Cookies used

Various types of cookies are used by SCP Srl, depending on their purpose, as described below.

#### Technical cookies

This type of cookie permits a number of sections on the Site to function correctly. They are divided into two categories, persistent and session cookies:

- persistent: once the browser is closed, these are not destroyed, but remain until their set expiry date
- session: these are deleted whenever the browser is closed

These cookies, always sent from our domain, are necessary for the Site to be viewed correctly and, in connection with the technical services offered, will therefore always be used and sent, unless the User modifies his browser settings (altering the display of the website pages).

#### Analytic cookies

Cookies in this category are used to collect information on the use of the Site. The Company reserves the right to use this information to develop anonymous statistical analyses and to improve user experience on the Site, thereby making the contents more interesting and relevant to his particular wishes. This type of cookie collects, in anonymous form, data on the User’s behaviour and how he reached the Site. Analytic cookies are sent either from the Site or from third party domains.

#### Google Analytics with anonymized IP (Google Inc.)

Google Analytics is a web analysis service provided by Google Inc. (“Google”).

The information generated by cookies are transmitted by the user’s browser to Google and saved on servers in the United States and other countries. Google will process this information on our behalf in order to evaluate your use of this website, drawing up an activity report and supplying us with other services relating to activities on the Site and on the Internet. The IP address obtained through Google Analytics will not be associated with any other type of data in Google’s possession. You can choose to disable or block Google cookies by selecting the relevant settings on your browser. In this way, you will not however be able to benefit from all the functions available on the Site. You can download and install

### Third-party service analysis cookies

These cookies are sent from third party domains external to the Site.

### Cookies for integrating third party software products and functions

This type of cookie integrates functions developed by third parties within the pages of the Site, such as icons and preferences expressed on social networks, in order to share the contents of the website and for the use of third party software services (such as software for generating maps and other software that offers additional services). These cookies are sent from third party domains and partner websites that offer their functions on the pages of the Site.

### Profiling cookies

SCP Srl does not use third-party cookies to manage the tool that remarkets the contents of the website. This tool allows the contents of personalised Google announcements to be published on the web on the basis of users' visits to our site.

The pages on our site include a code that allows browser cookies to be read and set up and thereby establish what type of announcement the user will view, on the basis of data relating to his visit to the site. For example, the user may view offers for announcements in the category previously viewed on the [scponline.it](http://scponline.it) website.

The user may modify the cookie reception setting by modifying the Privacy settings, as described under "How can cookies be disabled?" in this policy statement.

### Chrome

Open the Chrome Browser

Accept saving of data locally

Modify local data only until the browser is closed

Block sites from setting cookies

Block third party cookies and site data

Handle exceptions for some Internet sites

Remove one or all cookies

### Mozilla Firefox

Open the Mozilla Firefox Browser

### Internet Explorer

Open the Internet Explorer Browser

Click on Tools and select Internet Options

Click on the Privacy panel and under Settings, change the slider according to the desired action for the cookies:

Block all cookies

Accept all cookies

Select the sites from which you wish to obtain cookies: move the cursor to an intermediate position so as not to block or allow all cookies, then click on Sites, add the Website address in the Website address box and then click on Block or Allow.

### Safari 6

Open the Safari Browser

Click on Safari, select Preferences and press Privacy

Under Block Cookies specify how Safari must accept cookies from websites

To view the websites that have stored cookies, click on Details

Open the Safari iOS Browser

Click on Settings and then Safari

Click on Block Cookies and then choose one of the options: "Never", "Third parties and advertisers" or "Always"

To delete all cookies stored by Safari, click on Settings, then Safari and finally Delete Cookies and data
