

INFORMATION ON PROCESSING OF PERSONAL DATA (PRIVACY STATEMENT) pursuant to article 13 of Regulation (EU) 2016/679

The aim of this statement

In accordance with Regulation (EU) 2016/679 (hereinafter referred to as the "Regulation"), this page describes the methods adopted to process the personal data of users visiting the SCP Srl website, accessible online at the address www.sconline.it.

This information does not relate to other websites, pages or online services that can be reached via hypertextual links published on the sites yet referring to resources external to the SCP Srl domain.

Data Controller

When visiting the aforementioned website, data relating to identified or identifiable natural persons may be processed.

Legal basis of processing

The personal data indicated on this page are processed by SCP Srl in order to manage its website and to supply the services requested, such as, providing information, or informing the user about SCP Srl products or services.

SCP Srl may also contact you through research surveys conducted to obtain your opinion of current services or new services that may be made available in the future.

Types of data processed and purposes

Navigation data

During normal operations, the computer systems and software procedures used to operate this Website acquire certain personal data whose transmission is implicit in the use of Internet communication protocols.

This category of data includes IP addresses or domain names of computers and terminals used by users, the URI / URL notation addresses (Uniform Resource Identifier / Locator) of the requested resources, the time of the request, the method used to submit the request to the server, the file size obtained in response, the numeric code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the operating system and the user's computer environment.

These data, necessary for web services to be used, are also processed for the purpose of:

- obtaining statistical information on the use of the services (most visited pages, number of visitors by time or day, geographical areas of origin, etc.);
- checking the correct functioning of the services offered.

Navigation data are not usable for more than seven days and are deleted as soon as they are processed

Data supplied by the user

Cookies and other tracking systems

Cookies are not used to profile users, nor are any other tracking methods adopted.

Session (not persistent) cookies are used, on the other hand, to the extent strictly necessary to ensure safe and efficient navigation on our sites. The user has control over the storage of session cookies in terminals and browsers, where on the servers, when http sessions are closed, information relating to cookies remain recorded in the service logs. They are nevertheless stored, for periods not exceeding seven days, as are other navigation data.

Recipients of data

The following subjects, appointed by SCP Srl, pursuant to article 28 of the Regulation, as data processors, are recipients of data collected when a user visits the aforementioned websites. More precisely: FLY Web Srl in connection with the www.scponline.it site, providing development services, dealing with maintenance of the web platform, providing the development service, supplying and dealing with the operative management of the technological platforms used.

Personal data collected are also processed by personnel at SCP Srl, who operate in accordance with specific instructions regarding the purposes of processing and the methods to be adopted. SCP Srl does not sell or transfer this information to third parties in any manner whatsoever.

Removal from list of registered users

A user may request, at any time, that he or she be removed from the list of registered users, fully autonomously. Once he or she has connected to the SCP Srl site, the user will find the "Unregister" function amongst his or her preferences. As this function removes all data recorded, an e-mail confirming the operation cannot be sent.

Safeguarding your personal data

SCP Srl ensures that your personal information is safeguarded against unauthorised access, as it is saved and protected in a safe, controlled environment.

Modifications to privacy protection
